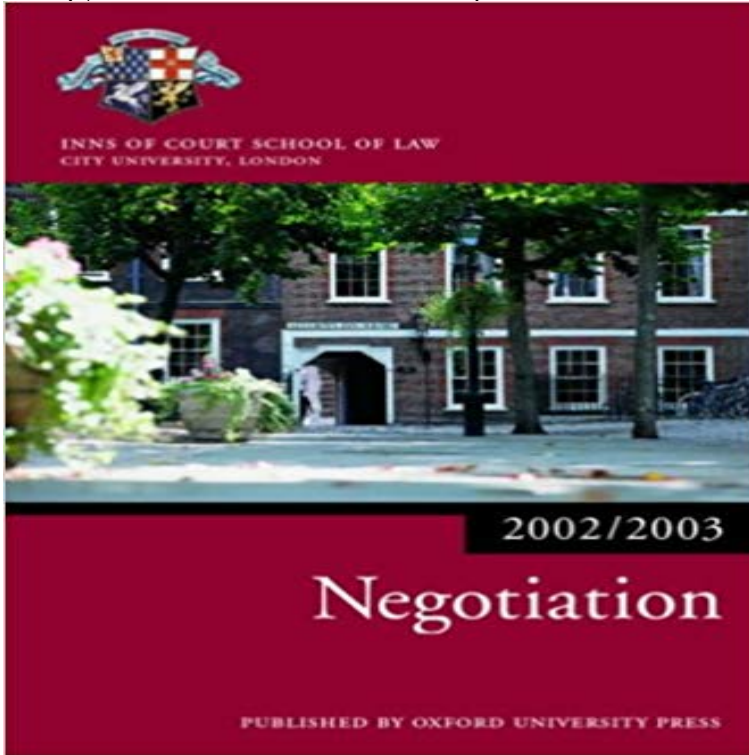


# Negotiation 2002/2003 (Blackstone Bar Manual)
