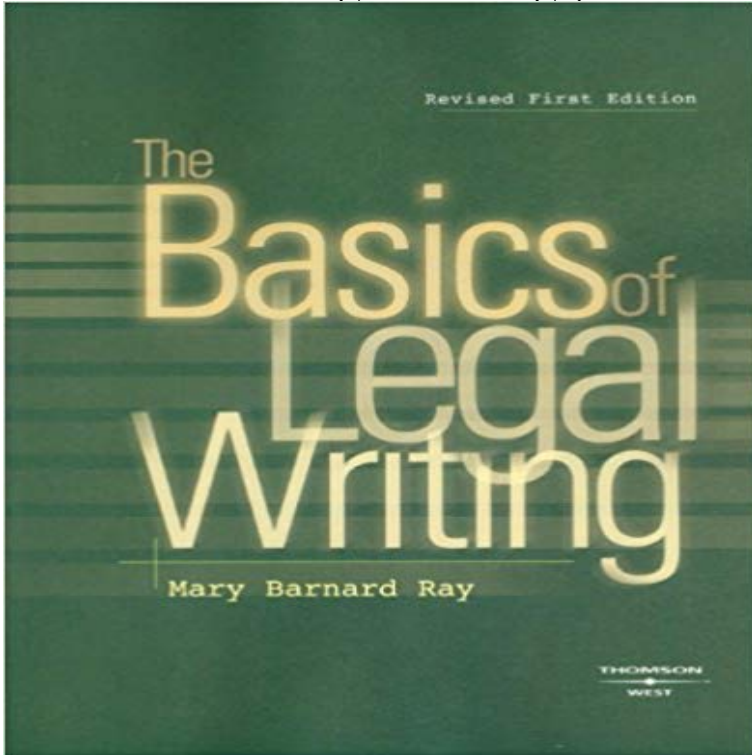


# The Basics of Legal Writing (American Casebook Series)
