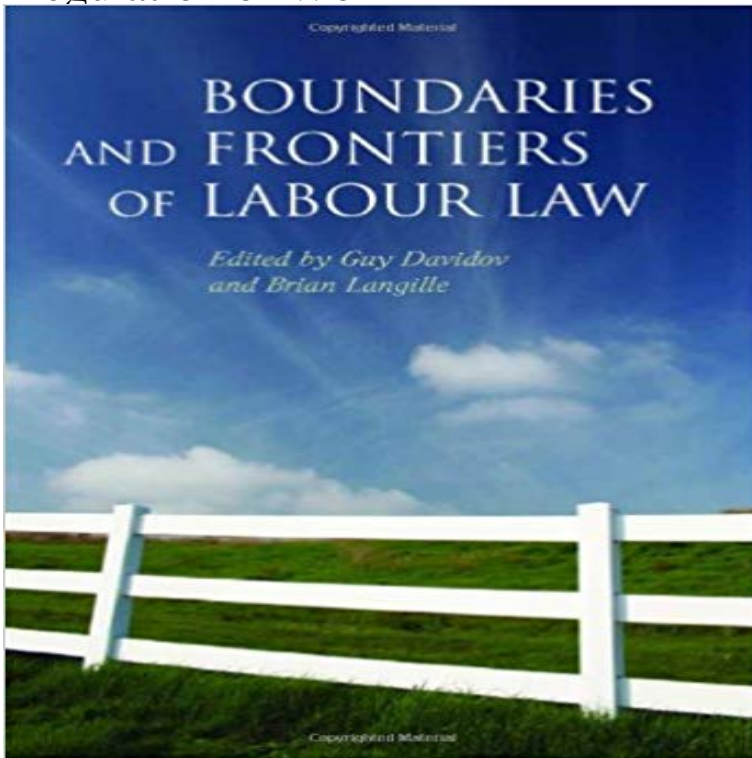


Boundaries and Frontiers of Labour Law: Goals and Means in the Regulation of Work
