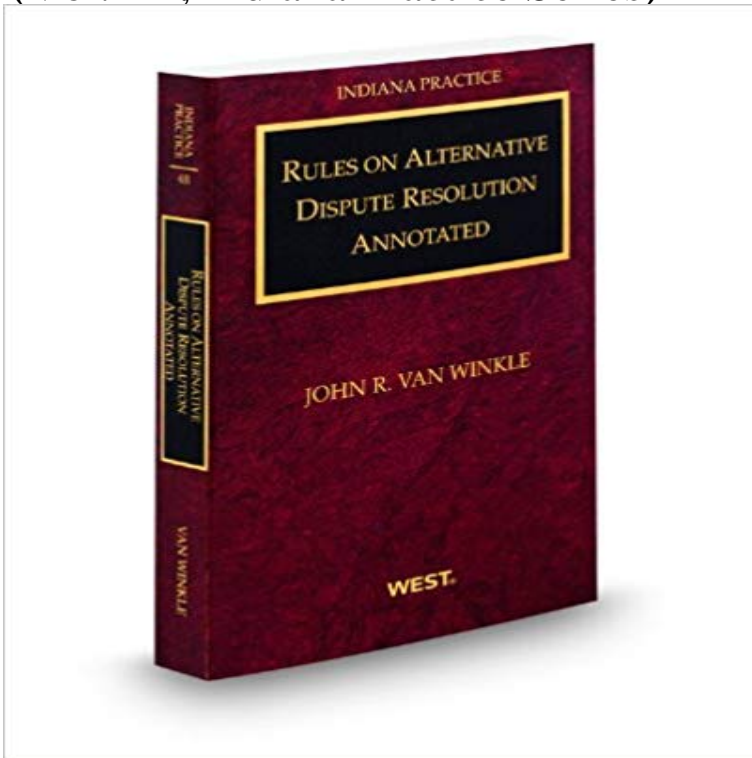


# Rules on Alternative Dispute Resolution Annotated with Forms, 2010 ed. (Vol. 4B, Indiana Practice Series)
